OUR HISTORY

While Ayusman Social Welfare Trust was formally registered in 2022, its journey began nearly ten years ago when a group of committed individuals came together with a vision to serve the underprivileged.

Over the years, this informal collective organized food distribution drives, health camps, educational aid programs, and other welfare initiatives. From aiding victims during natural calamities to supporting migrant workers during the COVID-19 lockdown, the trustees have always prioritized humanity over bureaucracy. Their on-ground experience and grassroots engagement have laid a solid foundation for the trust's registered operations.

OBJECTIVES

1. To provide food, clothing, and shelter to the poor and destitute.
2. To run health check-up camps and facilitate medical treatment for needy individuals.
3. To promote education among underprivileged children through scholarships, study materials, and tuition programs.
4. To empower women through training, self-help groups (SHGs), and microfinance support.
5. To work for the welfare of senior citizens and differently-abled persons.
6. To support environmental causes like afforestation, cleanliness drives, and water conservation.
7. To promote awareness on public health, hygiene, and sanitation.
8. To partner with government schemes and initiatives for social welfare.

KEY ACTIVITIES & INITIATIVES

1. Food Distribution Drives: Ayusman Social Welfare Trust regularly organizes food and ration distribution to homeless people, slum dwellers, and daily wage workers, especially during festivals and extreme weather conditions.

2. Medical Camps and Health Check-ups: Free health check-up camps, blood donation drives, and medicine distribution programs have been held in both urban and rural regions. Partnerships with local doctors and clinics ensure proper diagnosis and follow-ups.

3. Educational Support: The trust has sponsored school fees, distributed books, uniforms, and stationery to children from marginalized communities. Volunteers also conduct evening classes and mentorship sessions.

4. Women Empowerment: Ayusman Social Welfare Trust conducts workshops and training programs for women in tailoring, handicrafts, and small-scale entrepreneurship. Women are encouraged to become self-sufficient through SHGs.

5. COVID-19 Relief Work: During the pandemic, trustees worked on the ground to distribute food packets, masks, sanitizers, and basic medical aid to hundreds of families affected by lockdowns.

6. Rural Development: Sanitation awareness, cleanliness drives, construction of toilets, and water harvesting projects have been initiated in selected villages.
